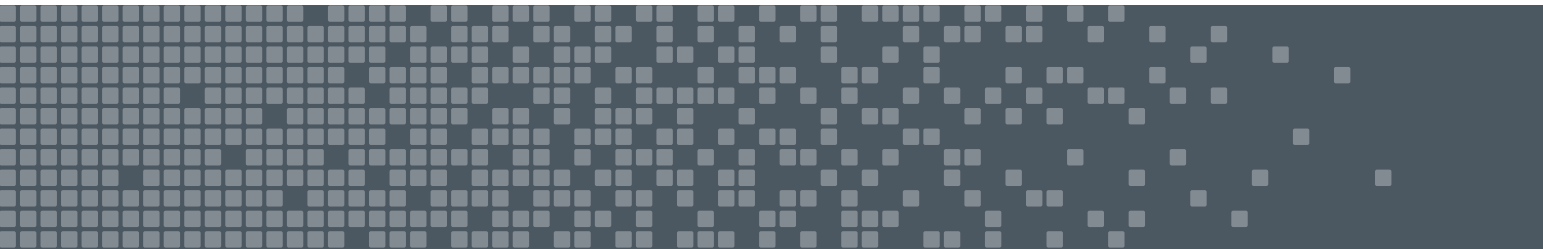

Back home, our Inclusive Cities Programme hit a major milestone with the launch of the 5th State of Urban Safety Report in South African Cities. This report marks a decade of impactful work by the Urban Safety Reference Group (USRG) and continues to serve as a critical tool in shaping safer, more secure urban environments.

Our Innovative Cities team hosted an engaging City Data Ecosystem Peer-Learning event, bringing together eThekweni Municipality and the City of Cape Town to share their data journeys and exchange ideas. Meanwhile, the Productive Cities team contributed valuable insights at the 6th Gauteng Environmental Research Symposium (GERS 6), advancing the dialogue on sustainability.

The Sustainable and Resilient Cities team continued the conversation with their 7th and 8th Cities' Lunchtime Chats, focusing on climate resilience and co-hosted with SALGA. 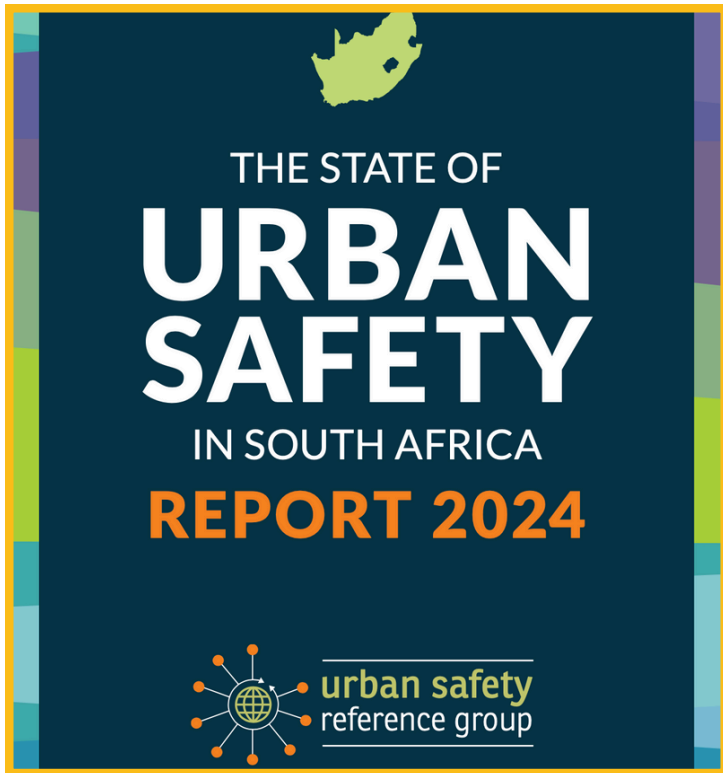

## Launch of the State of Urban Safety in South Africa Report 2024



On 11 December 2024, the South African Cities Network and its partners, the Deutsche Gesellschaft für Internationale Zusammenarbeit or GIZ and Global Affairs Canada (GAC), launched the fifth edition of The State of Urban Safety in South Africa Report. The 2024 Report, updating on trends and highlighting the work of the USRG in the period 2022 – 2024, also marks the 10th anniversary of collective, city-led efforts to learn, share, exchange, test practices and produce knowledge and evidence for safety governance across institutions with a role in safety.

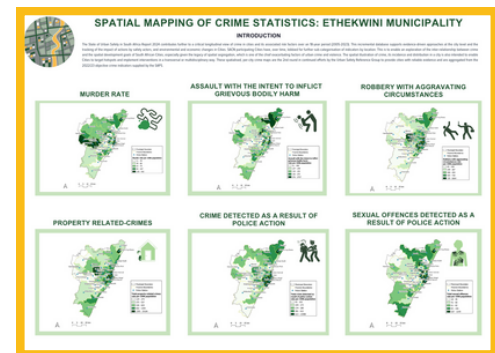
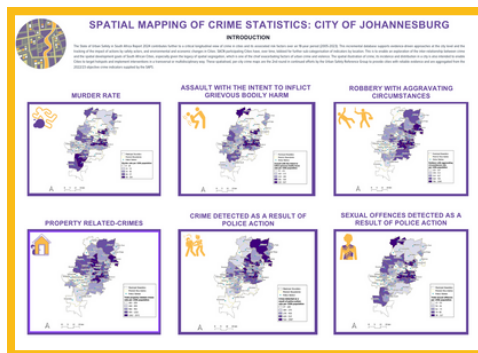
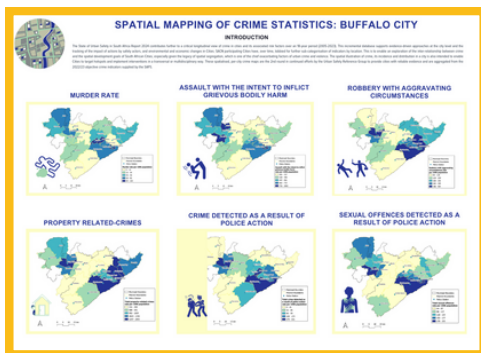
The 5th Report contributes to the USRG's longstanding objective of providing cities with an authoritative, incremental, longitudinal view of crime and violence to support evidence-based decision-making. In the last edition of 'state of' reporting, the USRG began to spatialise crime data, showing each city's true distribution of various crime types. This is incredibly empowering for their planning, collaboration, budgeting, and targeting, especially in the context of limited resources.

This edition departs slightly from the regular format of previous 'State of Urban Safety' Reports as it reflects on the last 10 years of city-led, structured engagement on the topic of urban safety.

While it does provide the usual updates on city crime trends, developments in relevant policy, and profiles of exemplary practices from South Africa's largest cities, this edition is especially exciting as it gives a clearer, more tangible sense of what safety is. It frames safety as not just a state of security but also our sensory experience of the public realm — what it smells, sounds, looks, and feels like when we feel safe or unsafe. This helps immensely to clarify and amplify the call for collaboration across sectors on safety.

The USRG has planned a robust engagement programme across key stakeholders in the following months regarding this Report.

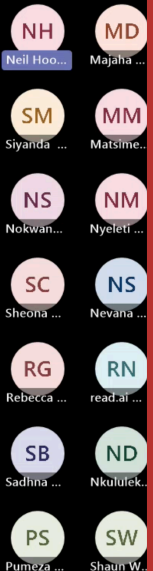

It was hosted by the Gauteng Department of Environment and held under the theme "Sustainability: Transition from Policy to Practice". This event brought together a diverse group of researchers, policymakers, industry leaders, and civil society to bridge the gap between research, policy, and practice in addressing socio-economic and environmental challenges.

One of the symposium's primary focuses was to facilitate productive collaboration, knowledge-sharing, and networking, and bridge the divide between research, policy, and actionable implementation.

## Governance Oversight and Learning Network (GOAL-N)

The second Governance Oversight and Learning Network (GOAL-N) workshop was convened on 30 October 2024 in partnership with the City of Joburg legislative support team. Researchers supporting MPAC from Ekurhuleni, Joburg, Nelson Mandela Bay, and Tshwane compared their systems and processes to deal with unauthorised, irregular, fruitless, and wasteful expenditures. In the new year, we hope to have the same discussion with Buffalo City, eThekweni, and Mangaung.

On 7 November 2024, the Community of Practice on Urban Governance and Municipal Finance held a webinar on the implications of the Electricity Regulation Amendment Act for municipalities. The panellists were:

- **Neil Cole**, Just Energy Transition Programme Management Unit.
- **Nhlanhla Ngidi**, Head of Electricity & Energy, SALGA.
- **Nndwamato Mutshidza**, Divisional Head of Energy Business, City of Tshwane.
- **Lerato Kgalema**, General Manager of Grid Access, City Power, City of Joburg.

The discussion touched on three questions:

1. How can municipalities identify financing models to support the transition to the new energy market?
2. What capabilities do municipalities need to develop to participate in energy trading effectively?
3. What role will independent power producers (IPPs) play in the new energy market, and how will this affect municipal utilities?

The panel also raised several concerns about the Act, the most important being the lack of prior consultation with municipalities on the impact of changes to their legislated role in electricity reticulation. The degree of municipal interest was reflected in the high attendance – 237 registrants – consisting of practitioners from Cape Town, Buffalo City, Ekurhuleni, eThekweni, Joburg, Mangaung, Nelson Mandela Bay, Tshwane, as well as Bhisho, Cape Agulhas (Bredasdorp), Drakenstein (Paarl), George, Hessequa (Riversdale), King Sabata Dalindyebo (Mthatha) Knysna, KwaDukuza, Mmabatho, Mossel Bay, Newcastle, Sedibeng, and Victor Khanye (Delmas).

Lastly, the Programme Manager, along with the Programme Manager Policy, Research, and Advocacy, attended a two-day inception workshop on 27-28 November convened by the Centre for Research on Democracy to start planning the first Citizen's Assembly in South Africa on climate change, which will be held in early 2026.

## Urban October kicks off with the National Urban Forum

The National Urban Forum took place from 9-11 October 2024 in Johannesburg in partnership with the South African Local Government Association (SALGA), Department of Cooperative Governance and Traditional Affairs (CoGTA), Department of Human Settlements (DHS), UN-Habitat and the South African Cities Network (SACN). The objective of the Forum aimed to highlight the strategic importance of managing rapid urbanisation in the context of responding to other megatrends such as climate change, smart mobility, and technology. It aimed to facilitate dialogue among government, civil society, private sector, and community organisations to promote sustainable urban development. Human Settlements Minister Mmamoloko Kubayi delivered an address on “The Global Habitat and Urban Agenda and the South African Urban Policy”.

SACN CEO Nosipho Hlatshwayo facilitated a session on the Challenges and Opportunities Shaping our Urban Landscapes, and our Programme Manager: Inclusive Cities, Kayla Brown, participated in a panel discussion on Urban Planning for Sustainable Human Settlements. The National Forum was a precursor to the Twelfth Session of the World Urban Forum (WUF12), convened by the UN-Habitat, which took place in Cairo, Egypt, in November 2024.

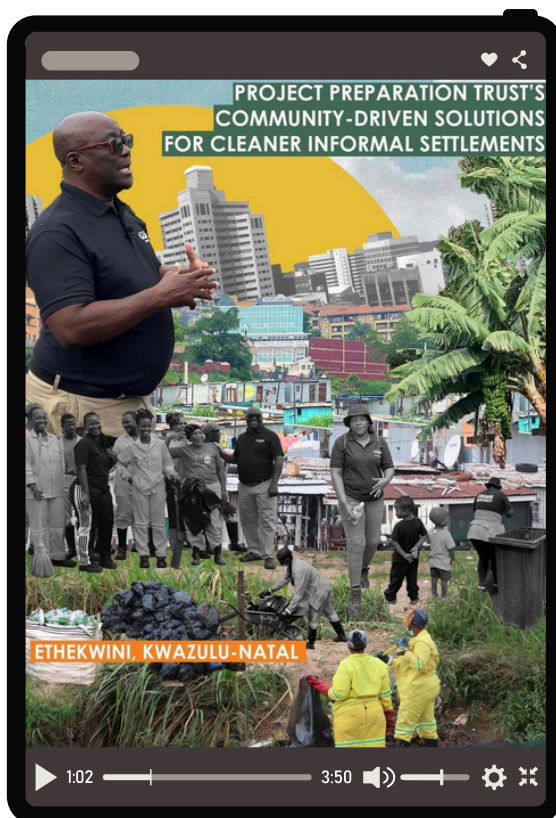

## SACN marks World Cities Day 2024 with the launch of Good Hood Stories Season 3!

The Good Hood Stories celebrate creative and collaborative city-making practices taking place across South African neighbourhoods. The third season of the Good Hood Stories has been created in partnership with the Department of Human Settlements, focusing on **transforming informal settlements**. The new season was launched on 31 October 2024.

Two exceptional projects were featured, demonstrating two important aspects of informal settlement transformation: the delivery of sanitation services and solid waste management. Project Preparations Trust's partnership with eThekweni Municipality on solid waste management and Asivikelane's gender-responsive service delivery in Knysna, Western Cape, both feature highly collaborative community-led approaches to informal settlement upgrading, which are championed through partnerships between different urban sectors.

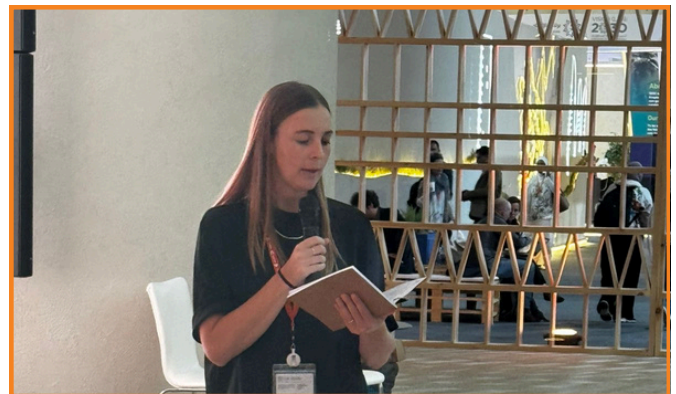
## SACN at the 12th World Urban Forum in Cairo, Egypt, 4-8 November 2024
